SAFETY GUIDANCE --- (From the FAA web site)

To fly under [The Exception for Recreational Flyers](#), you must:

- J Have a current registration
- J Fly only for recreational purposes
- J Follow the safety guidelines of a community based organization
- J Keep your drone within your visual line of sight
- J Give way and do not interfere with any manned aircraft
- J Fly at or below 400' in controlled airspace and only with prior authorization
- J Fly at or below 400' in uncontrolled airspace
- J Comply with all airspace restrictions
- J Pass The Recreational UAS Safety Test
